# Your Vale – Your Future: consultation on development in this area

Consultation on development during the next 20 years in the Vale of White Horse District Council area will take place during January and February 2009.

The main impact on Chilton will be a proposed development of a further 2,300 new homes to the west of the already agreed Great Western Park site at Didcot. This will effectively fill in the remaining open countryside between Didcot and the A34. The redevelopment and intensification of Harwell Science and Innovation Campus will also be promoted.

The consultation document identifies new road schemes to take the additional traffic between Didcot, Harwell Campus and the A34 southbound. One is a north to south link between the A4130 (the Didcot to Milton link road) and the A417. This would join the A417 east of the A34, close to West Hagbourne village.

How the traffic would then continue to Harwell Campus and the A34 is where it begins to affect Chilton. One possibility is a Rowstock bypass, which would relieve congestion at the existing Rowstock junction, but would direct more traffic on the A417 through the southern part of Harwell village. And no doubt increase use of the road over Hagbourne Hill.

The other option is a Chilton Link from the A417 to the A34 either by a completely new road or by regrading of the existing road over Hagbourne Hill. Both the Chilton links put forward so far would direct more traffic past the village and the school entrance off

the A4185, making it even more difficult for drivers to leave at peak times.

The Parish Council made its views known when the consultation document was discussed at a meeting of the VWHDC Development Control Committee at the beginning of this month. Just as well, because the Keep Harwell Rural campaign urged the Committee to adopt a route which may not be the preferred route of Chilton residents.

The Parish Council urges all Chilton residents to take part in the consultation at the beginning of 2009. The public consultation exhibitions (from 3.00pm to 7.00pm) and discussion groups (from 7.00pm to 9.00pm) will be held on

A little background information: Lvdia Thomas was a benefactress of Chilton who died in 1807 and provided in her will the sum of £333-6-8d in 3% Consols for distribution of £10 each New Year's Day for the benefit of the poor. The endowment was administered by the Churchwardens and Overseers of the Parish and used for a distribution of goods, usually of loaves of bread. It is believed that Lydia lived at the Malt House in Main Street. In 1975 the Fund was amalgamated with the Chilton Aid Fund (set up in 1955) to form the present day Fund. The Chilton Aid Fund arose from the Chilton share of the proceeds of the sale of the Nurse's House administered in connection with the Harwell and Chilton Nursing Association. That charity was comprised in a conveyance dated 1926.
